Subject: Deposit of Admissions Data Management Fee (ADMF) for the Academic Session(s) 2016-17, 2017-18, 2018-19 and 2019-20 in the Haryana State Technical Education Society (HSTES)-Furtherance of decision in CWP No.19073 of 2020 namely Association of Private Self-Financing Institutions of Haryana Versus State of Haryana and others.

Kindly refer to the subject noted above.

It is informed that in the Meetings held on 29-7-2020 and 4-8-2020 under the Chairmanship of W/DGTE-cum-VC,HSTES, it was decided to direct the institutions against whom ADMF fees for the past academic sessions is pending to submit an Undertaking on the prescribed proforma to be submitted on Stamp Paper that the institutions will deposit outstanding Admission Data Management Fees of Haryana State Technical Education Society for the Academic Sessions 2016-17 to 2019-20 by 04.09.2020. Further, the institute will also undertake(s) that in case, the institution does not deposit the Admission Data Management Fees by the due date, the institute will authorize the Haryana State Technical Education Society to deduct the amount of outstanding Admission Data Management Fees of the institution for the Academic Sessions 2016-17 to 2019-20 from the fees of the institutions in total collected by the Haryana State Technical Education Society. In case, the institution does not deposit the ADMF by 4.9.2020 or does not submit the Undertaking on the prescribed format, the names of candidates admitted will not be updated on the portal of HSTES. However the date of submitting of undertaking was extended upto 5.10.2020 and date for submission of ADMF fee was extended upto 23.11.2020 and a letter dated 28.10.2020 was issued to all concerned institute to submit undertaking that they will deposit pending dues of ADMF by 23.11.2020 and in case the amount due is not recovered even after deduction from admission fee collected by HSTES on behalf of concerned institute, the concerned institute shall not be considered for making admission for the year 2021-22. Further the institute who have pending dues and does not submit the undertaking, shall not be considered for admission for the session 2020-21 as decided earlier. In pursuance to that your institute has not submitted the undertaking and was not allowed to make admission:

In this connection, it is informed that Association of Private Self-Financing Institutions of Haryana has filed the case vide CWP No.19073 of 2020 titled as Association of Private Self-Financing Institutions of Haryana Versus State of Haryana and others in the Hon'ble Punjab and Haryana, High Court, Chandigarh. The same came up for hearing before Hon'ble Division Bench comprising of Hon'ble the Chief Justice and Hon'ble Mr. Justice Arun Palli on 11.11.2020 and Hon'ble Court has disposed of this case by passing the following orders:

“Learned Counsel for the petitioner after arguing at length submits that the respondent- authorities may be directed to consider and take a decision on the representation dated 05.10.2020 (Annexure P-15) filed by the petitioner. Learned Counsel for the petitioner undertake that they shall deposit the amount of ADMF with the respondent-authorities on doing so, the respondent be directed to consider the representation.

Mr. Ankur Mittal Learned Additional Advocate General, Haryana submits that in case the petitioner makes the deposit, the respondent authorities will consider and take decision on the representation filed by the petitioner expeditiously in accordance with law within two weeks from the date of deposit of the amount of ADMF by the petitioner. He further submits that in case the petitioner deposits the amount of ADMF with the authorities and if it is the sole ground for their being delisted from the list recognized affiliated colleges, they shall also take decision on including their names in the list of approved colleges in accordance with law subject to clearing the entire arrears of ADMF.

In view of the aforesaid, the writ petition stands disposed of.”

In furtherance to the orders of the above cited orders of Hon'ble Punjab and Haryana High Court. you are requested to pay pending dues of ADMF of Rs. _____ by 01.12.2020 so that the orders of Honble Court be complied with. It is made clear that if your institute does not pay the dues by last date, your institute will also not be included in the list of institutes in the concerned brochure for the session 2021-22. It is further made clear that the complete responsibility of admitting the candidates without paying the outstanding ADMF, will lie solely on the part of the your institute.

The outstanding Admission Data Management Fees can be transferred in HSTES Saving Account No.0087000111222785 IFSC Code No.PUNB0008700 Sector-17-B, Chandigarh. After the transfer of dues, the institute will intimate to this office on the performa attached with this letter on our email at admfhstes@gmail.com and copy of the same may also be sent by registered post for record. The ADMF data along with this forwarding letter is available on the website of HSTES "www.hstes.org.in".
