
In the Meetings held on 29-7-2020 and 4-8-2020 under the Chairmanship of W/DGTE-cum-VC,HSTES, it has been decided to direct the institutions against whom ADMF fess for the past academic sessions is pending to submit an Undertaking on the prescribed proforma to be submitted on Stamp Paper that the institutions will deposit outstanding Admission Data Management Fees of Haryana State Technical Education Society for the Academic Sessions 2016-17 to 2019-20 by 04.09.2020. Further, the institute will also undertake(s) that in case, the institution does not deposit the Admission Data Management Fees by the due date, the institute will authorize the Haryana State Technical Education Society to deduct the amount of outstanding Admission Data Management Fees of the institution for the Academic Sessions 2016-17 to 2019-20 from the fees of the institutions in total collected by the Haryana State Technical Education Society. In case, the institution does not deposit the ADMF by 4.9.2020 or does not submit the Undertaking on the prescribed format, the names of candidates admitted will not be updated on the portal of HSTES.

In this regard, it is again directed to ensure to deposit the pending amount of Admission Data Management Fee (ADMF) for the Academic Session(s) 2016-17, 2017-18 2018-19 and 2019-20 in Un-Aided branches of Aided Institutions and all Private Institutions in the State of Haryana by 4-9-2020 to be transferred in HSTES Saving Account No.008700011222785 IFSC Code No.PUNB0008700 Sector-17B, Chandigarh and intimate this office accordingly without any further delay otherwise the institution will be responsible for this lapse. The institutes are further directed to intimate this office on our email at admfhstes@gmail.com and also through Speed Post so that the amount deposited by the institute could be settled in the books of the Society. 

Subject: Admission Data Management Fee

With regard to the subject cited above, it is informed that 18th meeting of BoG of HSTES was held under the Chairpersonship of Smt. Dheera Khandelwal, IAS, ACSTE-cum-Chairperson, HSTES on 01.04.2016 and it has been decided that:

"The Intake Processing Fee (Rs. 200/- per admission) being charged from Self Financing Institutions on centralized admissions be dropped and Admission Data Management Fee (Rs. 200/- per admission) be charged one time by HSTES in respect of all admissions (Centralized Admissions and Institute Level Admissions) in Self Financing Institutions including un-aided branches of Aided Institutions from the academic session 2016-17. The said Fee be charged from the admitted students by the concerned institute and be credited/ deposited in HSTES account."

So, it is informed that action in this regard may be taken accordingly.
