As per the decision taken in Agenda Item No.18.27 of 18th BoG meeting held on 01.04.2016, it has been decided that the Intake Processing fee (Rs. 200/- per admission) being charged from self-financing institutions on centralized admission be dropped and Admission Data Management Fee (Rs. 200/- per admission) be charged one time by HSTES in respect of all admissions (Centralized Admissions and Institute Level Admissions) in Self Financing Institutions including un-aided branches of Aided Institutions from the academic session 2016-17. The said fee be charged from the admitted students by the concerned institute and be credited/deposited in HSTES account.

In order to avoid further consequences in this matter, the institution are hereby directed to deposit the Admission Data Management Fee (ADMF) with the HSTES otherwise suitable action will be taken against the defaulter institution by the department.

As the All India Council of Technical Education has extended the last date of admissions up to 30-11-2021, it is directed to ensure to deposit Rs. _____ on account of pending amount of Admission Data Management Fee (ADMF) for the Academic Session 2020-21 in Un-Aided branches of Aided Institutions and all Private Institutions in the State of Haryana by **12-11-2021** to be transferred in HSTES Saving Account No.0087000111222785 IFSC Code No.PUNB0008700, Sector-17-B, Chandigarh as per proforma enclosed with this letter without any further delay otherwise the institution will be responsible for this lapse. The institutes are further directed to intimate this office on our email at hstesadmf@gmail.com and also through Speed Post so that the amount deposited by the institute could be settled in the books of the Society.
