Kindly refer to this office memo no. 908-1434 dated 13.06.2023 the subject noted above.

In this regard, it is intimated that HSTES office has regularly demanded the pending ADMF for the session 2016-17 to 2023-24. As per the decision taken in Agenda Item No.18.27 of 18th BoG meeting held on 01.04.2016, it was decided that Admission Data Management Fee (Rs.200/- per admission) will be charged by HSTES in respect of all admissions (Centralized Admission and Institute Level Admission) in Self-Financing Institutions and un-aided branches of Aided Institutions from the academic session 2016-17 and onwards.




It is directed to ensure to deposit the pending amount as mentioned in the list of "Pending ADMF data from 2016-17 to 2023-24" available on the website <https://hstes.org.in/ADMF> on account of ADMF for the students admitted in un-aided branches of aided institutes and all private institutes in the state of Haryana by end of the next month. It is also directed to ensure to update the same on the portal available on the website <https://hstes.org.in/ADMFdepositform> (copy attached).

Amount is to be transferred in HSTES Saving account no. 100030641768 IFSC code no. INDB0000090, Indusind Bank, Sector-11 Panchkula. The institutes are further directed to intimate the deposit on email at hstesadmf@gmail.com and also through speed post so that the amount deposited by the institute could be settled in the books of HSTES. This data along with the forwarding letter is available on the website of HSTES www.hstes.org.in

However if any amount of ADMF is already deposited by the institute up to 2023-24 and still showing as payable in the list on website the same should be reconciled with the HSTES by informing the details (date of deposit and amount thereof) on email at hstesadmf@gmail.com

05. Enter Transaction ID/Challan No.
06. Enter Transaction Date.
07. Upload proof of Transaction (copy of Challan/Transaction proof in PDF format under 100 Kb in Size)
08. Enter Email ID of Institute. (Email will be sent about transaction confirmation)
09. Enter Remarks if any.
10. Enter Captcha verification.
11. Click on Submit Button.
