- \*These seats would be final for admission to Diploma Engg. Lateral Entry for the session 2025-26. Seat Matrix of Diploma Engg. Lateral Entry for the session 2025-26, shall be prepared according to Total Intake submitted by the institute. The institute shall be responsible for the discrepancy, if any.
- The Institution applied for Closure (if the same is under process/ approved for Progressive Closure) are eligible for admission to the Lateral Entry in the current Academic Year, as Extension of Approval was issued in the previous Academic Year and students were admitted during that year.
